


- COVID-19 cases are on the rise


Blue indicates previously reported deaths that occurred by date.








- 7000+ Covid related lawsuits in the courts
- 80+ are related to workplace safety
 - PPE issues
 - Cleaning, disinfecting, and sanitizing issues
 - Whistleblower protection guidelines
- Best Practice is to follow existing OSHA Standards to protect workforce from exposure to hazard



- Have a PLAN COVID-19 Preparedness & Response Plan
- Determine YOUR Exposure Risk Very High, Medium, Low
- Follow the "Hierarchy of Controls" concept





- Tasks should be evaluated for the possibility of working remotely
- Meetings/conferences and trainings should be done via the internet/virtually
- Employee-to-employee contact should be eliminated by spreading out workstations
- Employees should be encouraged to stay home if they feel ill in any way



- Workstation barriers
- Sneeze guards for cashiers
- Isolation of tasks should be considered where possible
- Increase ventilation, air exchanges and percent outside air



Administrative & Work Practice Controls

- Social Distancing
- Personal Cleanliness
- Work Surface Cleanliness
- Employee Training on COVID
- Additional Refresher Training (if workforce has been away for extended period)



Personal Protective Equipment (PPE)

- Gloves
- Masks and Respirators
- Body Protection
- Eye/Face Protection
- PPE Training
 - When & Why to use
 - How to don/doff
 - How to dispose of or disinfect
 - Understand the limits of PPE



- Fleet of Drivers
 - Cleaning of vehicles daily (per shift)
 - Drop & Go
- Supply Chain Concerns
 - Dedicated delivery locations
 - Aggressive cleaning & sanitation protocols in warehouses

- Develop and implement a plan to respond to all phases of the pandemic
- Train all staff in the plan and what to expect
- Continue to communicate your facility's status to employees as the pandemic progresses
- Documented records of inspections and cleanings validate the work has been completed
